# WHAT ARE THE HOA DUES AT LAUREL HEIGHTS?

During construction the monthly HOA dues are estimated to vary from \$374 - \$521. Monthly HOA dues are currently estimated to be \$439 at buildout. The HOA dues cover exterior maintenance, limited insurance, maintenance of the community amenities and common areas, recreational facilities and maintenance of the private streets.

The tax rate for the current year is 1.185% of the purchase price. Yes, there are special assessments in the amount of \$136.85 per month.
